3. That the school management is bound to pay the monthly and other compensations to the Teaching Staff and Non-Teaching Staff as Government employees after taking the affiliation from C.B.S.E. New Delhi and it is also declared that if it is not done then the no objection certificate shall be terminated.
4. It is also agreed by your school management that your management is bound to provide the necessary information at any time required or asked by the District Education Officer or Education Department or any of its Senior Authority.
